Bruce King & Stephen Couchman - Kolapore Wilderness Trail Association

Bruce King and Stephen Couchman attended to celebrate the 50 years of the Kolapore Wilderness Trail Association. They spoke of the evolution of the trail and the six kilometers of the trail that is in the County's forest. The Kolapore area provides an opportunity for all generations of trail users. The value of volunteers was acknowledged. Mr. Couchman thanked Grey County for providing support to the effective management of the area.

Peter Dunbar & Doug Symonds - Road Safety at Grey Road 4 and Sideroad 35 in Grey Highlands

Peter Dunbar attended to speak about road safety at Grey Road 4 and Sideroad 35 in Grey Highlands. Mr. Dunbar spoke of accidents at this intersection and outlined potentially contributing factors. The delegation recommended daylighting at the intersection by removing bushes affecting stop sign visibility, adding advance notice of stop signs on both approaches, increasing the size of the stop signs, illuminating the signs with solar power, and adding rumble strips.

Amendment No. 20 to the County of Grey Official Plan

The Constitutional Statement

Part A – The Preamble does not constitute a part of the Amendment.

Part B – The Amendment consisting of the following text and Schedule, constitutes Amendment No. 20 to the County of Grey Official Plan

Part C- The Appendices attached hereto do not constitute part of this Amendment.

These Appendices contain background data, planning considerations and public involvement associated with this Amendment.

Part A – The Preamble

Purpose

The purpose of the County Official Plan Amendment (File # 42-07-060-OPA-20) is to re-designate a portion of the subject lands (~0.87 ha) from 'Rural' and 'Hazard Lands' to 'Primary Settlement Area.' The redesignation would facilitate new development opportunities on the unused portion of the existing Township-owned Maple Grove Cemetery site, which is proposed to be added to lands to the north, for incorporation within a future plan of residential subdivision.

Location

The lands affected by the proposed Official Plan Amendment are described as Part of Lot 229 Concession 3 South West of the Toronto Sydenham Road Proton being Part 1 Reference Plan 16R8057; Southgate.

Basis

The subject lands are owned by the Township of Southgate, who is the applicant. A Planning Justification Report has been prepared in support of the proposal, and to address the requirements of the Planning Act, Provincial Policy Statement (PPS) and the County Official Plan. During pre-circulation discussions, County and Township staff agreed that the proposal would constitute a very minor expansion of the Settlement Area of Dundalk. An Amendment to the Township Official Plan and Zoning By-Law were reviewed concurrently with the County's OPA.

The County and the Township held a joint public meeting February 28, 2024. Oral and written comments were received and are summarized in the staff report. Agency comments are detailed in Planning Report PDR-CW-16-24, which can be found at Appendix D.

The minutes from the public meeting are attached as Appendix C.

Based on the supporting material, the Official Plan Amendment was recommended for approval to the Grey County Committee of the Whole. The reports of the Planning Department (PDR-CW-06-24 and PDR-CW-16-24) are included in Appendices B and D.

Part B – The Amendment

All this part of the document entitled "Part B – The Amendment" consisting of the following text and Schedules constitutes Amendment No. 20 to the County of Grey Official Plan.

Details of the Amendment

The Official Plan of the County of Grey Planning Area is amended as follows:

Page 4

1. Schedule A – Land Use Designations – Map 1 is hereby amended by changing the designation of the lands shown on Schedule 'A' affixed hereto from the 'Rural' and 'Hazard Lands' land use designation to the 'Primary Settlement Area' land use designation.


Implementation and Interpretation
