

É Minutes Committee of the Whole

September 14, 2023

Call to Order

Grey County Council met on the above date at the County Administration Building. Warden Milne assumed the Chair and called the meeting to order at 10:15 am with all members present, except Councillors Mackey, McQueen, Nielsen, and Boddy. Alternate Councillor Koepke attended on behalf of Councillor Boddy. Councillors Matrosovs, and Bordignon participated virtually.

Declaration of Interest

There were no declarations of interest.

HRR-CW-12-23 - Award of NRFP-HR-02-23 HCM Capital Project

Delegations

Jane Mizanski, Gallagher Benefit Services Group

Jane Mizanski, Gallagher Benefit Services Group, introduced the development of the non-union compensation program and pay equity review. The consultant noted that the County's last non-union compensation review occurred in 2013 and spoke about the interim measures undertaken during this period. The consultant described the background to the review, noting changes to the labour market and disruption or pressures facing the municipal sector, such as retirements and diminishing numbers of candidates.

Councillor Mackey joined the meeting electronically at this time.

The consultant reviewed the requirements and ongoing considerations for pay equity legislation. The consultant spoke about the tools and systems to analyze and improve internal pay equity, including the results of a market review of ten upper-tier municipal comparators. The consultant reviewed how positions can be realigned with market-competitive pay bands and salary grid.

Councillor McQueen joined the meeting electronically at this time.

In response to questions from the Committee, the consultant noted considerations for cost of living and confirmed that adjustments are incorporated annually through the budget process. The consultant confirmed that cost of living considerations were largely comparable to the selected market comparators. Further, the consultant discussed the implications of realigning the pay bands and salary grid using the 50th percentile.
