Call to Order

Grey County Council met on the above date at the County Administration Building. Warden Milne assumed the Chair and called the meeting to order at 10:11 a.m. with all members present except Councillor Pringle. Councillors McQueen, Nielsen, and Bordignon participated electronically.

Councillors Paterson, Dickert, Eccles, and Hutchinson declared a conflict of interest concerning the closed meeting item listed as item 8 on today's agenda and did not participate in any discussion or vote related to this item.

Business Arising from Minutes

Committee of the Whole – November 23, 2023 – Notice of Motion – Councillor Matrosovs

WHEREAS the vehicle and active transportation current and future needs and demographics have evolved since 2011 in the quadrant described as from Highway 26 between Grey Road 19/21, to Grey Road 19 from Grey Road 21 to Highway 26, Grey Road 21 from Grey Road 19 to Highway 26;

WHEREAS implications of alterations and detours will affect traffic on Town roads in this quadrant;

WHEREAS current demographics and needs of the area are not what was predicted over a decade ago;

WHEREAS there is new information about potential future development in the quadrant unknown over a decade ago;

WHEREAS Grey County endorses active transportation in Going Green in Grey.

NOW THEREFORE BE IT RESOLVED That Grey County Council direct staff to engage in further collaborative meetings and communication with the Ministry of Transportation, Simcoe County, and The Blue Mountains regarding:

- 1. Grey Road 19 from Jozo Weider Blvd. to Grey Road 21;
- 2. the intersection of Highway 26/Grey Road 21; and
- future roundabouts at Grey Road 19/Crosswinds Blvd. and Grey Road 19/21;

And Be It Further Resolved That Grey County coordinate with The Blue Mountains to arrange these meetings and communication to address traffic flow issues, consider active transportation options and safety, and update cost requirements of upper and lower tiers for Council's consideration.

Delegations

Tom Allwood - Multi-Municipal Energy Working Group - Battery Energy Storage Systems

Tom Allwood presented to the Committee as part of the Multi-Municipal Energy Working Group regarding battery energy storage systems (BESS). The presenter spoke about the new storage capacity sought by the IESO and the application process. The presenter highlighted concerns for battery energy storage systems regarding fire safety and emergency preparedness, noise or light emissions, unconfirmed regulations or decommissioning requirements, setbacks or separation distances, the development of prime agricultural land, and minimal notice or consultation requirements.

In response to questions, Tom Allwood discussed concerns about BESS applications within the region, the variable proprietary technology used, the lack of technical guidelines provided when requiring municipal support, fire safety and emergency response consideration, water sources and runoff for fire suppression, and the lack of consultation with neighbouring municipalities or other stakeholders, such as the Niagara Escarpment Commission. Further, the presenter discussed how municipalities can join the working group and the role of batteries and pump storage in Ontario's energy system.
