

Minutes Committee of the Whole

February 8, 2024

Call to Order

Grey County Council met on the above date at the County Administration Building. Warden Milne assumed the Chair and called the meeting to order at 10:11 a.m. with all members present. Councillors Dobreen and Bordignon participated electronically.

Declaration of Interest

There were no declarations of interest.

Business Arising from Minutes

There was no business arising from the minutes.

Delegations

Peter Frise, MTE/Voxtur Assessment - Tax Policy Overview

Peter Frise, MTE/Voxtur Assessment, presented to the Committee regarding Ontario's property tax and assessment system, considerations for Grey County's current tax policy, and the current tax and tax policy landscape.

Mary Lou Spicer described a recent training session held by Peter Frise with area Treasurers and the following discussion about aligning movement on the multi residential tax rate. The Director shared that the tax policy by-law would be brought forward in March to set rates and that information would then be provided to the member municipalities so impacts can be calculated.

In response to questions from the Committee, Peter Frise spoke about the convention of notional tax rates to measure and communicate changes accurately. Further, the presenter and staff spoke about considerations for tax policy, reassessment and shifting burdens between tax classes, including for properties within the farm class.

The meeting recessed and reconvened at 11:15 a.m.
