## **Delegations**

Jason Moretto, Envest Corp - Grey County Bioenergy Presentation

Jason Moretto of Envest Corp presented to the Committee about bioenergy and local renewable energy opportunities. The presenter provided an overview of the company and reviewed previous energy projects in Ontario and the United States of America.

Further, the presenter described the proposed renewable energy project in Southgate, including the location, site details, public consultation, and project partnerships.

In response to questions from the Committee, Jason Moretto described the separation of organic and inorganic materials for the creation of biofuels, the production process and licensing requirements for the liquid fertilizer bi-product produced, the transition to renewable natural gas systems, and efforts to capture and pressurize the CO2 produced for sale and the processing of municipal organics programs.

The meeting recessed and reconvened at 1:00 p.m.
