7.0 Medical Officer of Health Update

7.1 Opioid Situation Grey Bruce (STANDING ITEM)

The Physician Consultant provided an update regarding opioid and unregulated drug toxicity for Grey Bruce. There are four components being focused on:

Surveillance, data, primary prevention and secondary prevention. There is the SOS team to follow up on the overdose events. If there are overdoses that happens with SOS clients, the team will be made aware. If the event is repeated, the situation can be followed more closely. For the opioid stewardship through the committee in the hospital our Harm Reduction Manager will work on some primary intervention action. Also will work with Indigenous Committees especially through HBHC. In the process of having an agreement with Saugeen First Nations on evaluating their HBHC program and will audit some of their services to improve the service and adding things that are related to childhood experiences.

Based on a discussion between the Medical Officer of Health (MOH) and board member Nick Saunders, the MOH is seeking the Board's approval to explore two interventions (agreement under Section 50 of the Health Protection and Promotion Act, and liaison arrangement with the hospital boards) that have been identified to support the Indigenous Communities in improving health and is inviting a decision to identify other potential interventions.

The Board directed the staff to proceed with exploring the two interventions.

Moved by: Helen-Claire Tingling Seconded by: Sue Carleton "THAT, the Board of Health defer appointing a liaison between the Grey Bruce Public Health Board of Health and the Brightshores Hospital Board until staff provide a full proposal after communicating with the Ministry and Brightshores about reactivating the liaison position."

7.2 Strengthening Public Health (STANDING ITEM)

The Medical Officer of Health provided an update regarding the ministry announcement for strengthening public health. The Ministry announced they are reviewing Public Health Standards so recent communication from the leadership table for public health is they will be looking at quick wins before the changing of the standards. Additionally, there is the 1% increase in funding for public health and the team is looking at how we can internally adjust our operations to maximize our ability to continue our services. Once these efficiencies have been identified, they will be brought to the Board of Health. Lastly, there is the voluntary merger piece. Within the Southwest health units, at this point there does not seem to be any health units moving towards a voluntary merger. The situation will continue to be monitored and updates will be provided to the Board of Health.
