

Minutes Committee of the Whole

March 28, 2024

Call to Order

Grey County Council met on the above date at the County Administration Building. Warden Milne assumed the Chair and called the meeting to order at 10:18 a.m. with all members present except Councillor Pringle. Councillors McKay, Hutchinson, Matrosovs, and Bordignon participated electronically.

Declaration of Interest

There were no declarations of interest.

Business Arising from Minutes

There was no business arising from the minutes.

Delegations

James Scongack, Chief Development Officer and Executive Vice-President - Bruce Power Update

James Scongack presented to the Committee to share an update on Bruce Power. The presenter spoke about the pressures the hydro and electricity sector faces, including considerations for energy policy and security, affordability and economic implications, and sustainability and climate change. The presenter described the significant increase in demand for electricity and clean energy due to the projected growth in Ontario and long-term planning that balances the importance of maintaining current infrastructure while investing in innovation towards growth for greater capacity or more efficient technologies. The presenter explained the importance and opportunity of producing medical isotopes used to sterilize, diagnose and treat cancer. The presenter recognized their partnership with the Saugeen Ojibway Nations and Bruce Power's commitment to doing things better and differently going forward and engaging with the broader public and community. The presenter noted the importance of working with partners at all levels of government to ensure the necessary resources and infrastructure are in place to support the sector and the people in it.

Warden Milne thanked the speaker for recently receiving the Bruce Power Community Leadership Award.

In response to questions from the Committee, James Scongack discussed the importance of a collaborative teamwork approach between the levels of government to meet residents' needs and the opportunity to leverage this project's importance to Canada and the world for community improvements and support. Further, the presenter described Ontario's mix of energy sources, how reliable baseload nuclear supported by a base of hydro energy, the challenge of decarbonization being filling the gap left by fossil fuels and addressing peaking energy needs, and the continued role that fossil fuels will play in Ontario's mix of energy sources. The presenter spoke about the goal of Net Zero by 2050, the importance of both public-private partnerships for investment to address the size of the challenge, how energy storage is complimentary to the nuclear sector, and the importance of energy storage to address the peaking currently filled by the use of fossil fuels.
