Delegations

Alexis Cook, Community Safety and Wellbeing Coordinator & Robert Martin, West Grey Police Chief - Grey Bruce Community Safety and Wellbeing Planning Update

Anne Marie Shaw, Director of Community Services, spoke about the establishment of the Grey Bruce Community Safety and Wellbeing Planning initiative and introduced the delegation.

Alexis Cook, Community Safety and Wellbeing Coordinator for Grey and Bruce Counties, spoke about the multi-faceted and holistic approach to Community Safety and Wellbeing Planning. The presenter reported on the provincial CSWBP framework and the development of action tables, priority areas informed by regional data and stakeholder engagement, and current initiatives. The presenter reviewed the community partners supporting the Situation Table for Acutely Elevated RISK (STAR) Action Table, the interventions to lower risk for local communities or individuals, and their results in 2023 and 2024. The presenter spoke about the CSWBP objectives for 2024 and 2025.

In response to questions from the Committee, Alexis Cook spoke about the cost savings and prioritization of services provided by the interventions through CSWBP initiatives or STAR interventions. Further, the presenter explained tracking top risk factors and the supporting services. Robert Martin, West Grey Police Chief, discussed the changes in transient crime, the displacement of crime from urban areas that travel into rural communities, and the increase of survival-related criminal activities, which has been the focus of regional police services. Chief Martin recognized and thanked Alexis Cook for her work.

The meeting recessed and reconvened at 11:13 a.m.
