

Minutes Committee of the Whole

October 10, 2024

Grey County Council met on the above date at the County Administration Building. Warden Milne assumed the Chair and called the meeting to order at 10:22 a.m. with all members present except Councillor Bordignon. Councillor Hutchinson participated electronically.

Delegations

Thorsten Arnold - Urgent Need to Avert Threat of Drinking Water Disaster in Bruce-Grey's Karst Regions

Thorsten Arnold presented to the Committee regarding possible threats to drinking water contamination for private wells in the karst aquafer regions of Grey and Bruce County. The presenter described contributing factors, including karst geology, agricultural intensification, and mixed residential-agricultural land uses, and reviewed policy examples and research conducted in the United States.

Urban Road and Road Exchange Task Force minutes dated September 6, 2024

That the following resolutions contained therein be endorsed:

i. That report TR-UR-27-24 Urban Road Task Force Review be received; and That the responsibility for the maintenance and capital repair of the urban road segments noted in Table 1 of this report be approved in principle for transfer to the appropriate lower tier municipality with a target date beginning Fall 2025; and That staff be directed to negotiate new urban road agreements to take effect Fall 2025 with the municipalities noted in Table 1 and bring a report with the agreements and corresponding transition plans, including schedules, funding and maintenance support details, to a future Task Force meeting, for final approval of the transfer; and

That staff be directed to negotiate any agreements for continued county maintenance service on a cost recovery basis; and

That the urban capital transition funding model be approved in principle and referred to the Budget and Finance Committee for consideration.

ii. That report TR-UR-28-24 Rural Road Task Force Review be received; and

That staff work with member municipalities to confirm the administrative details necessary to enable the following exchanges and transfers and bring back a summary report to a future Task Force meeting:

- a. Exchange Southgate Sideroad 11 for Grey Road 14
- b. Exchange Bentinck-Sullivan Townline for Grey Road 25
- c. Transfer Concession 5 Derby and Concession Rd 6 to Grey County
- d. West Grey Concession 12 for Grey Road 9

That the Urbans Roads and Roads Exchange Task Force support the proposed financial model and average annual additional funding requirement up to \$2,095,880 for ten years as well as an increase of \$60,000 to the maintenance portion of the operating budget and that it be forwarded to the Budget and Finance Committee for budget consideration.

- b. That the County explore 'additional services' via the Rural Housing Information System/Rural Ontario Institute as may be needed to support access to data sources for populating a County-wide Housing Need Assessment template, to be funded from the proposed 2025 Housing Action Plan Implementation Budget, all of which is being funded from the Planning General Reserve; and

That this report be shared with Grey County's member municipalities for information purposes.
