9.2 RBC Mortgage Downpayment

The Senior Manager of Finance presented four options to the Board for the use of the surplus and recommended making a repayment of \$300,000 on the swap agreement that matures August 2, 2033. The recommendation would save approximately \$82,000 in interest over the remaining loan term.

10.2 Board Membership Update

The update referenced the correspondence from the Executive Council of Ontario renewing Mr. Chard Richards' membership on the Board of Health. The update also included the resignation of Mr. Luke Charbonneau from the Board of Health.

The Chair and Medical Officer of Health suggested an initiative to create a list of professional skills and competencies of Board members. Such list could be consulted by the Province and the two Counties in their considerations of future appointments to the Board. After discussion, the Board provided direction to the Medical Officer of Health to explore similar initiatives that are used by other Boards of Health, and to bring a summary of the finding in a future meeting.

10.3 Recognition of National Day for Truth and Reconciliation and Missing Indigenous Children and Residential Schools

Mr. Nick Saunders spoke to the impact and legacy of residential schools and the need for truth and reconciliation every day of the year. He emphasized that there is

more work we can do as a Public Health Unit to build meaningful relationships with Indigenous Communities.

It was suggested that the Board participate in a day of learning and training on the impact of residential schools and the issues facing Indigenous communities.
