

Minutes Committee of the Whole

November 28, 2024

Call to Order

Grey County Council met on the above date at the County Administration Building. Warden Milne assumed the Chair and called the meeting to order at 10:20 a.m. with all members present except Councillors Hutchinson and Dickert. Alternate Councillors Doug Hutchinson and Harold Fleet attended on their behalf. Councillors Pringle and Bordignon and Alternate Councillor Doug Hutchinson attended virtually.

Declaration of Interest

There were no declarations of interest.

Business Arising from Minutes

There was no business arising from the minutes.

Delegations

Lloyd Lewis - Road Safety on Grey Road 1

Lloyd Lewis and Fred Scheel, representing a group of concerned cyclists, attended to present concerns about bicycle safety on Grey Road 1. The presenters shared photos of the road's shoulders, spoke about traffic statistics, explained risks to cyclists, and shared emails of support. The presenters requested that the shoulders of Grey Road 1 be paved as a priority ahead of 2030 when it is scheduled.

Pat Hoy, Director of Transportation, confirmed that Grey County is supportive of paved shoulders and that the practice is to add paved shoulders when road work is being completed. Grey County has 877 km of roads. Of those, 259 km have fully paved shoulders and 231 km have partially-paved shoulders. Discussion included the ten-year capital plan and the process for determining priorities.

Stephanie Keating - Nuclear Innovation Institute - The Climate Project

Stephanie Keating attended to present the climate project which provides climate information relevant to Bruce, Grey and Huron counties. The information is divided into three categories: air, water, and land. The project supports decision-making, is a resource for educating communities, is a reliable source of data, and provides a sharing platform. The website for the climate project is climateproject.ca.

Annette Pedlar, Safe N Sound - Feasibility Assessment for Emergency Shelter and Letter of Support

Annette Pedlar, Executive Director of SafeNSound Grey Bruce, attended to provide an update on emergency shelter. Ms. Pedlar provided a historical progression of unsheltered people in the community, provided information on what services are available and how they are accessed and shared examples of situations that can result in life changes. SafeNSound asked for the County's support in the form of a letter of support for their Reaching Homes capital funding application.

CAO Wingrove asked Council if there was interest in hearing from Epcor who has been operating in Ontario for a number of years and is offering to provide an explanation to

councillors on what a P3 model looks like and considerations around P3s. Epcor offered to provide an open education session.
