CCR-JAAC-07-25 Accessible Customer Service Policy Update

JAAC10-25

Moved by: Member Sillaby Seconded by: Member Schnell That Report CCR-JAAC-07-25 regarding the updated Accessible Customer Service Policy be received; and

That Policy 5-1, the Accessible Customer Service Policy be amended as outlined in this report by amending the policy statement, including Grey Transit Route considerations, incorporating assistive devices and noting expanded training requirements.

CS-25-078 New Playground Designs at Comm-er-ette Park and Owen Heights Park

Eckhard Pastrik, Manager of Parks and Open Space for the City of Owen Sound, noted the potential accessible playground options suggested for each park within the City. He noted that there were two open houses hosted at each of the parks to invite members of the public for feedback.

The Committee asked for information on locations of accessible swings within the City and ways to find accessible swings and playgrounds in the area. Kathie Nunno, Accessibility and Contract Specialist for Grey County, noted that there is an interactive GIS map on the County website of accessible municipal spaces in the County, but noted that it does need updated. https://www.grey.ca/news/grey-county-launches-municipal-accessible-spaces-map

Councillor Greig shared the Accessible Playgrounds Ontario website where the public can look for information on locations for accessible playgrounds in the area.

The Committee sought clarification on the product that will be used on the ground of the playgrounds. Eckhard noted that the playgrounds will use engineered wood fibre. He noted that according to the CSA standard, this does meet accessibility requirements.

Flesherton Connecting Link

Grey Highlands staff Jackie Groves, Manager of Human Resources, and Mason Bellamy, Manager of Infrastructure, noted that critical improvement needs were

reviewed to update the main intersection in Flesherton including meeting requirements of the Ministry of Transportation for truck turning radius. With the close proximity of the main street buildings to the road, no rest areas were able to be included in the upgrades as well as accessible parking was not able to be accommodated.

Kathie Nunno noted item 80.31 in the Accessibility for Ontarians with Disabilities Act, 2005 and spoke to the exemptions from certain requirements under the legislation.

The Committee asked if proper audible crossings were able to be included where staff from Grey Highlands confirmed this was done as part of the project.

The Committee suggested posting a sign on the main road directing the public to the nearest accessible parking spaces.

Lorne Street Sidewalk Addition

Grey Highlands staff shared the proposal of a new section of sidewalk in Markdale down Lorne Street. The project is to complete an entire sidewalk network that is lacking, including repairs and correcting some deficiencies. Staff noted the increase of pedestrian traffic in the area due to travel to and from the Chapman's building.

The Committee sought clarification on the length of the sidewalk and where it leads. Staff noted that the project includes 160 metres of sidewalk running down a residential street.

There was no recommendation to add a rest area along this sidewalk.
